TUITION AGREEMENT SUMMER 2020

SUMMER TUITION DUE DATES:

- Camp Session 1 (6/15/20-6/26/20): June 15, 2020**
Camp Session 2 (6/29/20-7/10/20*): June 29, 2020 (*closed 7/3/20)
Camp Session 3 (7/13/20-7/24/20): July 13, 2020
Camp Session 4 (7/27/20-8/7/20): July 27, 2020
Camp Session 5 (8/10/20-8/21/20): August 10, 2020

PAYMENT LATE FEE:

- There will be a \$25 late fee incurred if your payment is not received by the summer tuition payment due date.

FORMS OF PAYMENTS:

We accept payments by:

- Checks
- Credit Cards. Credit card payments may be made by using the online link emailed to you in your invoice. Please note there is a 2.75% convenience fee if paying by credit card.
- We will no longer accept ACH payments for summer tuition payments.

DEPOSIT:

- There is no deposit required for families who are registered for the 2020/2021 school year.
- If your child is not registered for the 2020/2021 school year, a \$50 deposit is due for each camp session at time of registration. This deposit is non-refundable and will be applied to each camp's tuition fee.

POLICIES:

- Each camp is a two week session. You must sign up for the full two week session.
- You are responsible for the full tuition of the sessions you have registered for. We plan summer staffing and the summer budget on our summer enrollment figures.
- There will be no refund for absences, failure to attend the full term of the enrollment or withdrawal.
